## **SEPAC Business Meeting**

President Kathy Bent called the meeting to order at 5:45 p.m., welcomed everyone, and thanked Principal Kathi Amato for hosting the meeting.

Kathy stated the purpose of the meeting is to gather input for improving special education to submit to the district administration. ### Comments/Suggestions from Parents Included:

- A parent reported that after advocating strongly at her IEP review meeting last a team meeting was held in May with her child's new teachers to ensure that the new teachers had the IEP and would be ready for the beginning of the school year. This helped with the transition to 7th grade.
- Another parent reported a good transition to BUE for this school year.
- A parent with a child in the 18-22 year-old program (Transition Program) suggested that a name for that program be determined.
- A parent asked why curriculum for students receiving specialized instruction via special education was not in line with District K-3 curriculum and how this could be corrected. – Dr. Jezard responded that she did not have an answer.
- A parent asked how and when is it determined that a child be on MCAS-Alt instead of taking MCAS – Dr. Jezard responded that this is a team decision and should be revisited annually. If MCAS-Alt is in the IEP and the parent declines it, the parent needs to reject the MCAS-Alt.
- A parent asked how many children on MCAS-Alt graduate with a high school diploma. -- Dr. Jezard responded that she is not aware of any.
- A suggestion to have the Benefit Coordinator with Mass Rehab present was made Julie Clymer volunteered to make the contact and set up a meeting.
- Comment forms are available at each meeting and on the SEPAC website for those parents who cannot make meetings or who prefer to submit comments anonymously.
